The Chairman Elders' Committee HCBA, Allahabad-2025-26

Dear Sir,

As you are aware that our tenure of twelve months is expiring on May2nd, 2025. The byelaws provides further one month for the purpose of holding elections and if within this 13 month, elections are not held, the Elders' Committee is to hold the elections. In this regard, I am quoting the provisions of byelaws 18 and 55 for your kind perusal:-

"18. The office bearers of the Association and members of Governing Council shall hold the office till completion of one year from the date when new Executive Council takes over the charge. However, it will continue for one month more during which election of Executive Council has to be completed.

If the election of governing council is not held within one year and one month then after 13 months, Elders' Committee will take over the charge of Governing Council and will conduct the election within one month, during this period, administration power will implant in Elders' Committee. Elders' Committee will not take any policy decision however, perform day to day work, which is necessary in the interest of Bar Association.

<u>Explanation:</u> Date of election is date when the new Governing Council takes over the charge.

55. The Meeting of Annual General Body of the Association will be convened at least a month before the expiry of the term of the Office Bearers and shall fix a date for Election.

The Elders' Committee will act as Panel of the Returning Officers to hold Election and be entitled to include any other Member of the Association, provided one is not contesting the Election and the result of the Election shall be declared in the Meeting of the General Body, so convened by the Elders' Committee."

In this regard, the Annual General Body Meeting was held on 18.04.2025 wherein regard to election, the belowmentioned resolution was passed:-

"आम सभा में चुनाव की तिथि नियत करने पर सहमति नहीं बन पाई। कार्यकारिणी ने मई 2025 के आखिरी सप्ताह में चुनाव कराने की बात कही तो इस पर अधिकांश अधिवक्ताओं ने भीषण गर्मी और जून में छुट्टी होने के कारण जुलाई माह से पूर्व चुनाव न कराने का आग्रह किया जबकि अन्य लोगों द्वारा चैम्बर आवंटन होने तक चुनाव न कराने पर जोर दिया गया। यहाँ यह भी स्पष्ट है कि वर्तमान कार्यकारिणी का कार्यकाल बाईलाज की धारा 18 के अनुसार 02 मई 2025 को समाप्त हो रहा है और अधिकतम यह कार्यकारिणी 13 महीनों तक ही रह सकती है। अतः 02 जून 2025 के पूर्व चुनाव कराने की प्रक्रिया आवश्यक है। ध्वनिमत से यह निर्णय हुआ कि वर्तमान कार्यकारिणी इस सम्बन्ध में एल्डर्स कमेटी से भी सहमति प्राप्त कर जुलाई महीने में चुनाव कराने की प्रक्रिया शुरू करे और चूँकि यह चुनाव 13 महीनों के पश्चात् होगा इसलिए वर्तमान कार्यकारिणी अपना समस्त वित्तीय अधिकार (Financial Power) दिनांक 02.05.2025 को एल्डर्स कमेटी को सौंप देगी तथा एल्डर्स कमेटी से यह निवेदन करेगी कि वे जुलाई माह में चुनाव कराने की प्रक्रिया को स्वतः सुपरवाइज करें क्योंकि 02 जून 2025 के पश्चात् वर्तमान कार्यकारिणी किसी भी प्रकार के चुनाव सम्बन्धी कार्य के लिए सक्षम नहीं है। इस सम्बन्ध में एकमत से यह भी प्रस्ताव पारित हुआ कि चुनाव सम्बन्धी कार्यवाही में किसी भी प्रकार का कोई विलम्ब न हो। कार्यकारिणी भी इस बात से सहमत है।"

"आम सभा द्वारा सर्वसम्मित से निर्णय लिया गया कि दिनांक 18.04.2025 तक किए गये समस्त आय—व्यय का अनुमोदन किया जाता है तथा सर्वसम्मित से यह भी प्रस्ताव पारित किया गया कि जब तक नई कार्यकारिणी अपना कार्यभार नहीं ग्रहण कर लेती है, तब तक वर्तमान कार्यकारिणी पूर्व की भाँति अपना कार्य करती रहेगी।"

In view of the aforesaid resolution, we request you to take over all financial charges and account operation immediately w.e.f. 02.05.2025 and further be pleased to declare the date of election in the month of July, 2025 or as you thinkfit so that early election be ensured.

We shall be highly obliged.
